

Town of Burns
June 8, 2022
Town Board Meeting Minutes

1. The meeting was called to order by Chairman Nuttleman at 7:33 pm. Roll call: Chairman (Chr.) Nuttleman, Supervisor (Sup.) Caulum, Supervisor (Sup.) Hoth, and Clerk (Clk.) Hart-Pollock present. Treasurer (Tr.) Anderson was absent. Chairman (Chr.) Nuttleman noted the meeting was properly posted.
2. Tr. Anderson presented the Treasurer's report for April and May 2022. Available account balances in April total \$230,289.74 and Rockland Cemetery account balance is \$22,134.29. Available account balances for May total \$211,508.11 and Rockland Cemetery account balance is \$22,141.03. Chr. Nuttleman noted for the record that the April and May 2022 Treasurer's Report were received.
3. Motion by Sup. Hoth to approve the May 11, 2022 Town Board meeting minutes. Second made by Sup. Caulum. Voice vote, all ayes, motion carried.
4. Motion by Sup. Hoth to approve bills from May 12-June 8,2022, checks #11750-11777 and two EFTs from First National Bank. Second by Sup. Caulum. Voice vote, all ayes, motion carried.

 - Linda Saley reported her 4-H Club would like to upgrade the aluminum can collection shed to a larger wooden structure to replace the current plastic shed. She would like to have concrete poured as the same size as current shed. The 4-H Club will be paying for the concrete.
 - County Board Representative Jake Jacobson reported the following:
 - 90-100 miles of county roads need upgrading
 - Broadband: talked to the County Board. The county does not have funds allocated. Jacobson went to the Executive Committee, Monica states they're working on it, but not really. Clark, Jackson, and Monroe counties are in the process of providing broadband.
6. Town Zoning Administrator (ZA) Bill Larson reported the following:
 - Jane Johnson – discussed warning letter
 - Jay Johnson – his girlfriend's daughter had a mobile home moved to her land. Did not have septic inspected.
 - Phone call from an appraiser.
7. Chr. Nuttleman motioned to approve Ordinance #6-8-2022, #1 for resolution of fees for building permits and zoning occupancy permits. Second made by Sup. Hoth. Voice vote, all ayes, motion carried.
8. Chr. Nuttleman motioned to approve the Wisconsin Liquor License application from the West Salem Rod & Gun Club. Second made by Sup. Caulum. Voice vote, all ayes, motion carried.
9. Chr. Nuttleman motioned to approve the Operator License applications from the West Salem Rod & Gun Club. Which include Ervin Oldenberg, David Schauf, Thomas Garbers, and Tristan Johnsrude. Second made by Sup. Hoth. Voice vote, all ayes, motion carried.
10. Motion by Chr. Nuttleman to approve Ordinance No. 6-8-2022 #1. Whereas sec. 70.47 96m)(c) authorizes the appointment of alternate members to serve on the board to review when standing members are removed from individual cases; now therefore the Town Board of Burns, La Crosse County does ordain as follows: 1. ADOPTION Pursuant to Section 70.47 (6m)(c) and sec. 70.46(1) of Wis. Statutes the town board hereby provides for the appointment of alternates to serve on the town board of review on the event of standing board member of the board of reviews is removed or unable to serve for any reason. 2. APPOINTMENTS the following electors of the Town of Burns are hereby named as alternated in the order indicated to serve as alternate board of review members: Alternate 1- Linda Saley, Alternate 2-Liza Schlitz, Alternate 3-Sarah Langrehr, Alternate 4-Faith Wathke. EFFECTIVE DATE: The appointments made in this ordinance are for the Year 2022 Board of Review proceedings and effective upon posting as provided by law. Passed on the 8th day of June, 2022. 11. Motion by Chr. Nuttleman to approve State of Wisconsin Resolution No. 6-8-2022 #1. Resolution to Appoint Board of Appeals Members. I, Steve Nuttleman, the chairperson of the Town of Burns, La Crosse County, Wisconsin, as the appointing authority under s. 62.23 (7)€, Wis. Stats., for members of the board of appeals, hereby appoint Hunter Young and Tammie Nachtigal who are not town officials or members of the board of appeal, for the term of office of 2 years or to continue until replaced, to commence on April 17, 2021 and to expire on April 17, 2023. Wayde Pollock and Scott Nachtigal, who are not town officials or members of the board of appeals, for the term of office 3 years or to continue until replaced, to commence on June 8, 2022 and to expire on June 8, 2025. Passed on the 8th day of June, 2022. By the Town Board of the Town of Burns. Second made by Sup. Hoth. Voice vote, all ayes, motion carried.
12. It was reported the following regarding the owners of N9301 Williams Road, Mindoro:
 - a. Patrolman Holzhausen talked with Jay Johnson. Johnson states he will patch the gouges with hot mix.
 - b. Ben's name is listed because he has a valid drivers license.
 - c. Decided to give Johnson time to repair the roads. Deadline 7/15/2022. Clk. Hart-Pollock will send him a letter.
13. Chr. Nuttleman called Farmington on Wanless Road. Will ask for 75% of expenses due to damage.
 - Garbage & Refuse Report: Three old snowmobiles were dropped off. We are not a salvage yard. A lot of lumber from an old barn dumped off. A resident dumped off old meat into the large dumpster, rotting smell.
