- 1. The meeting was called to order by Chairman Nuttleman at 7:30 pm. Roll call: Chairman (Chr.) Nuttleman, Supervisor (Sup.) Hoth, Treasurer (Tr.) Anderson, and Clerk (Clk.) Hart present. Supervisor (Sup.) Caulum was absent. Chairman (Chr.) Nuttleman noted the meeting was properly posted.
- 2. Tr. Anderson presented the Treasurer's report for August 2022. Available account balances total \$225,669.83 and Rockland Cemetery account balance is \$22,163.96. Chr. Nuttleman noted for the record that the August 2022 Treasurer's Report was received.
- 3. Clk. Hart-Pollock reported the August 10, 2022, minutes will be available for the October meeting.
- 4. Motion by Sup. Hoth to approve bills from August 11 September 14, 2022, checks #11838-11875 and two EFTs from First National Bank. Second by Chr. Nuttleman. Voice vote, all ayes, motion carried.
- 5. Linda Saley reported the 4-H Club has recycled around 3,000 pounds of cans at Alter. John and Howard are doing great at the dump. The 4-H Club will not be building their can shed this year.
- 6. John Malphy proposed to change the hours of the Garbage and Refuse to be the same time frame all year long to prevent confusion for residents, shared ideas of updating the layout, and residents not disposing of their recycling properly.
- 7. Sup. Hoth motioned to change the hours of operation for the Garbage and Refuse Saturday's 8:00 am 1:00 pm and Tuesday's 4:00 pm 7:00 pm all year long. Second by Chr. Nuttleman. Voice vote, all ayes, motion carried.
- 8. Town Zoning Administrator (ZA) Bill Larson reported:
 - A Inlow: looking at solar panels
 - Resident inquired about replacing his roof on a 6x19 cabin.
 - J Austin: building a detached pole shed.
 - J Miles: inquired about building a 50 x 80 shed for his semi.
- 9. ZA Larson reported that the mobile home is now junk. Our Patrolmen repaired the road damage with cold mix. Need to contact the Town Attorney to discuss procedure to issue citation.
- 10. Clk. Hart-Pollock presented a letter of request from Sparta Area Ambulance Service, LTD for the annual service fee. Fee for 2023 is \$7,792. This is an increase from 2022 of \$80. The annual support for 2022 was \$7,712 and 2021 was \$4,820.
- 11. Patrolman Holzhausen discussed the culverts for Piske Road.
